

**INSTRUMENT OF GOVERNMENT FOR FEDERATED GOVERNING BODIES
(VARIATION)**

- 1 The name of the federation is: The Federation of Shalfleet Church of England (Controlled) Primary School and Yarmouth Church of England (Aided) Primary School.
- 2 The names and categories of the schools in the federation are:

Name	Category
1. Shalfleet Church of England (Controlled) Primary School	Voluntary Controlled
2. Yarmouth Church of England (Aided) Primary School	Voluntary Aided

3. The name of the governing board is: "The Governing Board of the Federation of Shalfleet Church of England (Controlled) Primary School and Yarmouth Church of England (Aided) Primary School."
4. The governing board shall consist of the following (this depends on the number and categories of schools in the federation under Part 4 of the Federation Regulations):
 - a. Two Parent governors
 - b. One Head teacher governor
 - c. One Staff governor
 - d. One Local Authority governor
 - e. Six Foundation governors
 - f. Three Co-opted governors
(The total number of co-opted governors who are also eligible to be elected as staff governors under Schedule 3 of the Federation Regulations, when counted together with the staff governor and the head teacher, must not exceed one third of the total membership of the governing body.)
5. Total number of governors: Fourteen
6. The name of the foundation body entitled to appoint foundation governors is: The Diocese of Portsmouth Diocesan Board of Education as follows:
 - a) One appointed by the Diocesan Board of Education after consultation with the Parochial Church Council of St. James' Yarmouth.
 - b) One appointed by the Diocesan Board of Education from amongst nominations from the Parochial Church Council of St. James' Yarmouth.

- c) One appointed by the Diocesan Board of Education from amongst nominations from the Parochial Church Council of St. Swithen's, Thorley.
 - d) One appointed by the Diocesan Board of Education after consultation with the Parochial Church Council of St. Michael the Archangel, Shalfleet.
7. (a) The holders of the following offices shall be foundation governors ex-officio:
- (i) The principal officiating minister for the parish of St James' Yarmouth,
 - (ii) The principal officiating minister for the parish of St Michael the Archangel, Shalfleet.
- (b) The Archdeacon of the Archdeaconry within which the school is situated shall be entitled to appoint a foundation governor to act in the place of any ex-officio foundation governor whose governorship derives from an office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21 of the Constitution Regulations or there is a vacancy in the office by virtue of which this governorship exists.
8. The Archdeacon of the Archdeaconry within which the school is situated is entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor.
9. There is a trust deed for Shalfleet School dated 1849 and for Yarmouth School dated 1854.
10. Recognising their historic foundation, the schools will preserve and develop their religious characters in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The schools aim to serve their community by providing an education of the highest quality within the context of Christian belief and practice. They encourage an understanding of the meaning and significance of faith and promote Christian values through the experience they offer to all their pupils.


